# Spine Pain Management, Inc. Expands Operations in Florida

HOUSTON, June 16, 2011-- Spine Pain Management, Inc. (OTC.BB: SPIN), through its Chief Executive Officer, William F. Donovan, M.D., is pleased to announce its expansion of operations into the Orlando, Florida area through a relationship with a new spine pain diagnostic center.

Through this relationship, the company will be able to facilitate medical spine injection procedures to patients from the central Florida area.
